Update on Meeting with PED

Thank you to all who came to Santa Fe for CAPE at the Capitol. We were able to inform all that came about a pending meeting with PED, and we tried to make sure everyone understood the concerns regarding PED.

CAPE did meet with PED and Representative Dow on Friday. CAPE requested that PED remove their interpretation of the homeschool law and leave the form with one signature rather than 15 initials. PED has tentatively agreed to put the actual homeschool law into the notification form rather than their interpretation of it. However, they have to get final approval which hopefully will come this week. Please continue to be in prayer that PED will come to a reasonable agreement. We will keep you informed as we get additional information.
